# \*\*\*STOP PRESS\*\*\* Substantial Amendment

We are preparing for a substantial amendment for submission in the next few months. At the moment we do not include posterior strokes so please make a note of interested patients who have had a posterior stroke as they may still be in time once the amendment is in place. We also intend to change the telephone screening from telephone, to face-to-face, at the research clinic. This will provide us with a more accurate picture of the patient's BP readings. So if you have potential patients, who currently don't meet the BP inclusion criteria with their last 3 BPs from their index event, but you feel their BPs in general are within range, then please make a note of their details. They may still have the opportunity to participate!

### **Tips of the month**

- Please include the informant as much as possible in the whole recruitment process. The informant may have a big influence on the patient, ensuring they continue to participate, the patient takes their prescribed medications and generally retains interest in participating in PODCAST!
- Newcastle have an excellent system in place to recognise potential recruits. The week before clinic the secretary sends the research staff the clinic list so the researchers can look through the list, identify potentials and then ask their medical staff to mention PODCAST to the identified patients.
- We are preparing for our next teleconference and plan to hold it on 18 April so please keep your lunchtime (12.30-13.30) free on that day and get in touch with any topics you wish to discuss or would like further information on.

### **PODCAST** password reset

The reset option is on the login page. You can use it to request an email, which will contain a link allowing you to change your password. The system will also ask you to set a second PIN, which should be memorable to you personally. This will not replace your original PIN, but will be requested if you should forget your password again in the future. If you do not know your main PIN, you will still need to call the PODCAST office to reset your password.

# What forms and documents to fax/send following randomisation

Please fax/send to the Co-ordinating Centre all consents (including screening consent), the patient and informant details, the ECG from the index stroke, all CT and MRI reports from time of index stroke, doppler reports, and the ABPM printout (if participating). The CT/MRI images must be sent via secure courier and we would like all brain images from the time of the patient's stroke until they have their final clinic appointment.
